## **BIOGRAPHY OR HISTORY**

The Dering family lived at Sylvester Manor on Shelter Island beginning with Thomas Dering and Mary Sylvester Dering in 1762. His son, Sylvester, became a General during the Revolutionary War. General Sylvester Dering I died in 1820 after being thrown from his horse. In 1827, the Dering family sold the manor property at public auction in Sag Harbor.
